## 06/25 Fixtures Database

#### a. Completed Issues

- i. Upload to British Orienteering web site by Fixtures Secretary now resolved
- ii. ER1 update to allow for higher entry fees and car park fees was put on hold due to incompatibility with import process to database.
- iii. Association Fixture Secretaries have advised clubs re the availability of the official's activity report from the fixtures database.

#### b. Outstanding Issues

- i. On line event registration: Pending, review of the BOF Management systems.
- ii. Wider publicity of C5 events: ER1S now has a Yes/No box for publicity. This needs to be further updated together with database to indicate Regional, National or None. National Fixtures Secretary to update form, Association Fixture Secretaries to advise clubs that the "box" on form ER1S requesting publicity needs to be ticked for C5 events, if they the club wants it to become visible on this list. Association Fixture Secretaries were asked to seek their club's agreement to this.

**Action:** Task has been passed to Michael Napier, work in progress, Fixture Secretary to monitor progress.

iii. The database does not have a field for major Event coordinators, so this activity is not recorded. It also needs extra fields for assistant organisers, controllers and planners.

**Action**: Amy Sarkies: To be included in the new membership system when produced.

#### 06/26 Major Events Procedures

a. Good progress has been made in the submission of ER1 partials for major Events. 2008 is complete except for SOA and EBOR Nationals.

**Action:** SOA position known, EBOR to submit ER1 partial for their National Event 3<sup>rd</sup>/4<sup>th</sup> May 2008.

b. Major events procedure document: The document was updated as the previous version was now out of date following the departure of Alex Ross.

#### **Actions:**

- i. Fixtures Chairman to take revised document to Event Operations for sign off on Saturday 14<sup>th</sup> October 2006.
- ii. Guidance document to be posted on to the BOF web site on the Regulations Section and Forms Section of the web site.
- iii. Form ME1 to be removed from Forms Section of BOF web site
- iv. Form ME2 to be revised and renamed MEO (Major Event Officials)
- v. A document listing advice to Grade 1 controller assessing Major Events has been compiled. To be posted on Regulations Section and Forms Section of the web site.
- vi. Article to be submitted for inclusion in Focus.

#### 06/27 Long Term Schedule for JK and BOC

- a. NIOA have offered to host JK 2011. This was welcomed.
- b. The advance planner sheet was discussed. A "line in the sand" approach has been taken from 2011 onwards. Associations that can host have then been allocated the JK and BOC at 5 year intervals from the last time they hosted. This will still require some compromise to put a viable schedule in place. If EMOA and EAOA combined to host then the schedule is more achievable or that they work with WOA to host a JK in Wales..

**Action:** Planner sheet made available to Association Fixture Secretaries for discussion with their associations for the March 2007 meeting.

#### 06/28 Any Other Business

#### a. Yvette Baker Trophy 2007

Action: Association Fixture Secretaries to ascertain 2007 events for March 2007 meeting.

#### b. Fixtures Budget

Fixtures have been allocated a budget for stationary costs, minor updates to the fixtures database and a contribution towards broadband costs for the National Fixtures Secretary. The sum is £400. Meeting costs are met from a separate budget.

#### c. Withdrawal of printed fixture lists with Focus

It is proposed to cease circulating the printed fixtures booklet with Focus. Members could seek a printed list from the National Office if they required one. All present felt the booklet was of little value. It was out of date by the time it went to print. It would appear Compass Sport will continue to print a copy of the approved list.

#### d. Membership Changes

It was agreed that published event entry fees for all fixtures should be the full fee before member's discount. Therefore these need to be the fees listed on the ER1

There was a need for a consistent approach.

Action: Association Fixture Secretaries to inform their clubs.

#### e. Event registration

- i. The procedure was queried concerning the registration of an orienteering activity by a club in an Association other than their home Association. It was agreed that all ER forms must be submitted via the Association Fixture Secretary/Club Fixture Secretary where the terrain is located.
- ii. There was also an issue of clubs registering events in multiple Associations on one ER1S. These are mainly RAFO and BAOC events, many of which are held on MOD land that is not controlled by clubs. It was felt that these should also be submitted in the same manner as **i** above.
- iii. The issue of individuals registering what were essentially commercial orienteering events via clubs to benefit from British Orienteering insurance was raised. It was agreed that it was not appropriate unless it was the club running and benefiting from the activity. Otherwise these registrations should not be accepted.

Action: Association Fixture Secretaries to inform their clubs about items i to iii above.

#### f. Fixture Appeals Process

Other parts of Orienteering have an appeals process. The view of the meeting was that Fixtures did not need an appeals process. They were content to put items to a vote and accept a Chairman's casting vote, if necessary. Fixtures are part of Event Operations, so there is a higher committee to take to disputes to.

#### g. Declaration of Interests

The Chairman queried if members of this Group were required to complete declaration of interest forms.

Action: Amy Sarkies to make enquiries and clarify the situation.
