Very simple updating of maps should be the responsibility of

the club and the clubs mapping officer.

Level 1 –Attend an introductory mapping course to facilitate

the production of a map of a simple area. The mapping course should consist of two parts, one on basic survey

techniques including a practical session and one on cartography using OCAD.

Level 2 – Submit portfolio of level C/D map files with

planner/controller report for assessment.

Level 3 – Attend an advanced map course or mapping conference; submit samples of recent level B/C mapping with reports.

M11/08 Appendix H

A complete review is required as a result of changes to the quality assurance system for maps. The revised document was discussed and amended section by section. The updated version will be circulated for comment before submission for ratification and publication.
