1. Welcome

The Chair, Judith Holt, welcomed attendees to the EGM.

General housekeeping and safety was explained by MH.

JH listed the Apologies for Absence.

2. Appointment of Tellers

JH Asked who would like to be appointed as Teller.

Mike Forrest from (BOK) was appointed Teller.

3. Proposals

Judith went on to explain in brief what the proposals were, these being:

Proposal 1: To include the Isle of Man in the territory over which British Orienteering governs the Sport

of Orienteering. The North West was keen to support.

Proposal 2: The Re-appointment of a Director (Basic Article tidy up:- to engage with younger people to

get on the Board and encourage previous Board

members to return)

Judith replied that if the vote was against then this would jeopardise 5 staff member positions. JH thanked Tony for his question.



4. Voting

The appointed teller then left the meeting room to count the votes along with the proxy votes held by the Chair and Others. The results were handed to the Chair, Judith Holt.
